- Completed Medical Declaration form
- Shire of York WHS Induction and volunteer Fire Brigade WHS induction (online)- approx. 30 mins
- One (1) Day training course -run by Troy Granville includes
 - AllIMS Awareness – (Online through DFES Volunteer Hub)
 - Bushfire Safety Awareness (or equivalent)

All Volunteers will need to meet the mandatory training requirements for the 2022/23 fire season.
