



# Director General's Report

August 2014

**Reform of WA's metropolitan local governments has moved closer, with the Local Government Advisory Board (LGAB) calling for public submissions on three proposals. LGAB will be putting forward its recommendations on reform to Local Government Minister Tony Simpson in late August.**

The Department of Local Government and Communities (DLGC) continues to support metropolitan local governments during the reform, including providing \$15 million over three years in grants to assist with implementation. A further \$45 million will be available from the State Government in low-interest loans.

Another exciting move forward for local government has happened in the Pilbara, where the Shire of Roebourne became the City of Karratha on 1 July. DLGC looks forward to continuing to work with the city as it embraces this milestone achievement.

DLGC's community funding programs are a great example of partnerships in action. Recently approved grants have been awarded under the community gardens and beyond gambling programs.

Another excellent example of government and community collaboration is Seniors Week, which is a partnership between DLGC and Council on the Ageing WA. As part of the event, local governments and community sector organisations are being encouraged to apply for a Seniors Week Community Grant to celebrate seniors in their local community. The WA Seniors Awards were also launched recently and DLGC and COTA WA welcome your nominations.

I hope you enjoy the August edition of the Director General's Report. As DLGC finds better ways of working and keeping our stakeholders informed, the report will soon be moving to an online publication. I look forward to sharing more from DLGC in the coming months.

## Reform moves a step closer

### The call for public submissions on three of the proposals received for local government reform in metropolitan Perth is another clear signal changes are getting closer.

The Local Government Advisory Board has advertised its intended recommendations on the three proposals submitted by the Cockburn Community Steering Committee, the City of Armadale and the City of Melville.

Board chairman Mel Congerton said that, as required by the *Local Government Act 1995*, the board was calling for public submissions on the intended recommendations that were significantly different from the original proposals it received.

The board is expected to complete its report by the end of August.

The final decision on the board's recommendations will then be made by Local Government Minister Tony Simpson who can accept or reject the recommendations, but cannot change them.

Minister Simpson has reaffirmed the State Government's commitment to the reform process and plans for new local governments to start operating from 1 July 2015.

## Roebourne clinches city status


### The Shire of Roebourne became the City of Karratha on 1 July in a ceremony attended by council representatives, members of parliament and local business leaders.

At the ceremony, Mayor Peter Long said the region had come a long way since its early pastoral and pearling days. The council had worked hard to improve the standard of infrastructure and the delivery of community services and facilities to meet the needs of the city's growing population.

The City of Karratha is home to 25,000 residents.

Under the *Local Government Act 1995* a shire can become a city when it has more than 20,000 residents, half of whom live in an urban area.

Achieving city status will help build the City of Karratha's profile and is likely to attract more investment, diversify the local economy and create better opportunities for residents and businesses.

## Grants commission welcomes new members

**The WA Local Government Grants Commission has welcomed new members. Shire of Manjimup councillor Paul Omodei has been appointed country rural member, City of Kwinana Mayor Carol Adams is the metropolitan member and Shire of Mundaring councillor Stephen Fox was appointed deputy metropolitan member.**

The commission has completed its calculation of the 2014-15 financial assistance grants and anticipates that about \$280 million will be distributed among 138 Western Australian local governments in local road and general purpose grants.

In the lead up to the 2015-16 grant determinations, the commission has identified tourism, FIFO workers, regional centres, expenditure on doctors and animal control as areas to be reviewed.

### WA Seniors Awards

A partnership between DLGC and Council on the Ageing WA (COTA WA), the WA Seniors Awards recognise seniors, and those who work with and volunteer for seniors, for their outstanding contributions to Western Australian communities.

This year age-friendly community sector organisations and age-friendly local governments will be recognised with two new award categories.

Nominations close on 29 August and finalists will be announced in October.

## Communities to bloom with new grants

### Community gardens

DLGC has approved grants of almost \$100,000 to establish community gardens in Gosnells and Willetton, support gardens in Broome and improve gardens in Victoria Park, Greenbushes, Mt Barker, Mandurah and Rockingham.

The projects were successful due to their sound planning and local government support. Community gardens are an important social hub for communities, providing sustainable food as well as knowledge-sharing.

### Reducing problem gambling

Projects that raise awareness and reduce the impact of problem social gambling have received a total of \$840,000 from the Beyond Gambling Grants Program. They include a youth radio project, an African youth recreation-based project and a diversion program for Aboriginal people in a Kimberley community.

## Mining scholarships a boost for women

Three West Australian women have been awarded the inaugural Women in Mining WA's (WiMWA) mentoring program scholarships. Sponsored by DLGC, the scholarships aim to help improve the economic independence of women and increase their participation in leadership roles.

The scholarship recipients are mining engineering graduate Stephanie Graskoski, geologist Sarah Connolly and chemical engineer Lacey Filipich. DLGC plans to continue its funding of the scholarships in 2015.

## Pilbara dance group wins top award

Port Hedland youth dance group The Hood Academy was chosen from the finalists of the Community Services Excellence Awards to win the prestigious Community Sector Choice Award. The youth-led hip hop academy was voted the stand-out favourite by attendees at the awards ceremony.

The Hood Academy was established in 2009 after boredom and anti-social behaviour were identified as major issues facing young people in Port Hedland. Dance is used as a tool to engage, equip and empower young people through initiatives such as peer mentoring and youth leadership.

The Community Services Excellence Awards are funded by DLGC, Lotterywest, Department of Regional Development, Synergy and the Water Corporation, with support from Hesta and Beyond Bank Australia.

## Protecting the role of carers

## Cultural training attracts diverse interest

**The popularity of the Office of Multicultural Interests' (OMI) Diverse WA program has resulted in it being rolled out to community sector organisations and considered for use by the Family Court of Australia.**

Diverse WA is a free online cultural competency training program that is being used by the public sector and local governments. More than 5,800 people from 117 public sector agencies and another 120 from local governments have registered for the program since its inception two years ago.

Due to demand, the program has recently been made available to community sector organisations and in the past three months more than 50 have registered to use the program.

## ABR cracks geocoding upgrade

**The Australian Business Register (ABR) has been upgraded to incorporate two new features. The new capabilities may help agencies with policy development and planning and support local governments in their response to emergency situations.**

One change is the geocoding of business location information in the ABR. Geocoding is a user-friendly, web-based tool that assigns geographic coordinates from street addresses, helping to build a detailed picture of business locations in Australia.

In addition, details about companies that have multiple physical business locations can now

be captured in the ABR. These addresses will also be geocoded and linked to statistical standards that will allow comparative analysis with other sources of information. More information is available by contacting the ABR on (02) 6216 4991.
