##### **1.1 Opening**

**RTG-002-14     STATUS REPORT – OUTSTANDING BUSINESS FROM THE SOUTH EAST  
AVON REGIONAL TRANSITION GROUP (SEARTG) BOARD MEETINGS**

The Chairman drew attention to this item of business, with the Executive Officer providing comment, summarised as follows:

- The only outstanding matter for the SEARTG Group which requires completion is the review Policies and Delegations for the four Participating Local Governments.
- These documents are partially complete.
- Responses are required from Participating Local Governments in relation to relevant Delegations.
- Once received, Delegations and Policies can be finalised.

### ***Item***

Review and Consolidation of Delegations and Administrative Policies:

- Pre release funding for the SEARTG Group included the following:
  - \$5,000 for the preparation of new Delegations for the Participating Local Governments and new entity.
  - \$8,000 Policy Manual – review current policy manuals for each Participating Local Government and develop new Policy Manual for the new entity.

### ***Comment***

Consultants have prepared Draft Delegations and are awaiting confirmation from Participating Local Governments as to which Delegations will apply to their respective Councils. The compilation of the Administrative Policies is dependent on finalising the Delegations component as the two documents will be linked.

The Chairman sought input from Chief Executive Officers, and confirmation that the SEARTG Group were happy to proceed with the finalisation of the Policy and Delegation review as detailed by the Executive Officer.

Feedback was provided in relation to Participating Local Governments concluding budgetary obligations prior to finalising their respective Delegations and Policies, with Mr G Fardon seeking clarification on SEARTG funding finalisation and how this relates to the project.

The Executive Officer advised that funding had already been provided for this project, therefore finalisation was assured, and that this had been detailed in the relevant funding acquittal.

It was then
