Dear Sirs,

After serving nine years as a Councillor in the Shire of York (2 years as President) it is with regret that I find it necessary to submit my resignation today. This is to take effect immediately and includes all duties associated with the position.

I sincerely thank those in the community who voted for me three times demonstrating their trust and confidence in me.

The reasons that I give are in part (but not only) contained in the Show Cause Notice issued by Minister for Local Government Tony Simpson and expanded upon in the Timeline/Chronology of Events E1439371. I endorse the accurate allegations made by the Minister for Local Government and his Department.

I find the Council to be dysfunctional in the extreme – one example being **NO** support for experienced and professional staff who have been constantly accused of incompetence (A vote of 3 for support and 3 against) Ignoring of professional auditors advice and the endless pursuit of unfounded allegations of credit card fraud by some in this Council is unacceptable.

The handling of the Fitz Gerald Report by the President is shameful and illegal – that is:-


1. A purchase order taken out without consultation with Council (Page 7 of E1439371)
2. An attempt to release it to the public without Council approval
3. No opportunity for rebuttal by those named in it even though it was ultimately leaked to the public and the media (The West Australian)
