Re: Recreational Vehicles Parking per Avon Riverfront Concept Plan

I am writing to you as the owner of the residential property at 22 Monger Street, York, which adjoins the riverfront recreation reserve south of Glebe Street.

By this letter I wish to voice my strong objection to the proposed construction of a hardstand parking area on the southern reserve for caravans in the manner envisaged by the Avon Park Riverfront Concept Plan and related Site Plan. I understand that the Site Plan was 'workshopped' at a Concept Forum organised by the Council some days ago on Monday 2 October 2017.

My property at 22 Monger Street, occupied by my husband and myself, is the property most directly affected by the RV hardstand proposal. But our first knowledge of the proposed work came to us by a letter dated 3 October 2017 from Paul Crewe (your Executive Manager Infrastructure); that is, a letter written after the Site Plan had been workshopped and apparently approved. Indeed, we only received the Shire's letter yesterday seeking my 'feedback on the relocation' of the RV hardstand area.

Mr Crewe has been courteous and helpful in providing information in response to our queries by phone but the fact remains – as indicated by the dates mentioned above – that there has been a lack of prior consultation with the property owner most directly affected. I have been unfairly denied an opportunity to set out some persuasive reasons why the proposed hardstand and related work (including access routes) should not proceed. I therefore request that this letter be circulated to councillors without delay and the Site Plan be reconsidered. I am making this request because it seems that the work in question may have been scheduled to commence next week (the week commencing Monday 16 October).

Our grounds of objection are as follows.

<u>First</u>, the hardstand RV parking area and related access routes are to be constructed on a public reserve set aside for recreation. The recreational purpose was principally intended to benefit the residents of York, not 24 hour itinerant caravan travellers. The Lands Department may be of the view that a 24 hour stopover usage won't infringe the recreational purpose designated by statute but any longer use would certainly be an infringement. The reality is that as caravans come and go to the hardstand area the south reserve will inevitably begin to look like a caravan park.

Second, Council planning policies are generally designed to preserve and enhance the amenity of an area, as illustrated by the Concept Plan proposals for the riverfront reserve north of Glebe Street. But it follows from the first point made above that the proposed hardstand and related usage by caravan on the subject reserve south of Glebe Street will damage the amenity of the area. What should properly serve as a quiet wilderness area for walking along the riverfront as an adjunct to the more active playground / barbecue etc facilities north of Glebe Street will have the look of a caravan park. There will also be vehicles moving to and fro for access and to use the proposed 'Dump Point' on the spare block on the corner of Monger and Glebe Streets. There will be an increased movement of vehicles along Monger Street. All of this is quite contrary to the usual planning principles aimed at preserving the amenity of the area.

<u>Third</u>, it is not clear to what extent thought has been given to other alternatives with a view to insulating the special qualities of these riverfront areas from the movement and parking of large vehicles. The normal practice would be to keep caravans and camping areas some distance away from the town centre.

<u>Fourth</u>, it is significant that under the original formulation of the Concept Plan the RV Parking location was placed fronting Glebe Street in the vicinity of Yorky's Coffee Carriage development. If some provision has to be made for RV close to the town centre it is difficult to see why this option has been dispensed with, and again without adequate consultation with those most affected. Our property will also be affected by the operation of the proposed new 'Dump Point.'

In summary, then, I contend that there has not been adequate consultation in this matter. Good reasons exist (as set out above) for the Council to give further consideration to the matters in issue. In the absence of any pressing need to begin the proposed work right away no steps should be taken until the matters raised in this letter have been fully considered. I am willing to discuss the matter with representatives of the Council or Council officers at short notice.

Re: RV Parking - Shire of York

Thank you for your letter dated 3/10/2017 re RV Parking in the area behind The Coffee Carriage.

Whilst we have no objection to the location of an overnight stay area as per the map, we do have strong concerns about access and related traffic safety issues. Those concerns are explained below. We ask that, if this plan is to go ahead, a comprehensive review of traffic management and the associated safety issues be undertaken.

Access road - size and suitability

Stephen Street is a narrow road with a sharp 90 degree turn into Thorn Street at the point where you suggest putting access to the parking area. The turn is difficult for longer vehicles and the power pole on the corner shows damage where vehicles have hit it in the past. Western Power looked at moving the pole some years ago after previous correspondence from us to the Shire, but decided at the time that the pole was in the appropriate place. There is also a telephone services point very close to the proposed entrance to the parking area.

Some caravans already use Thorn Street as an alternative route to Avon Park and have to negotiate this corner. Thorn Street is also narrow and has a lot of pedestrian/gopher traffic from Balladong Lodge and Lifestyle village. The houses in Thorn Street are part of the Central Heritage Precinct and are built close to the road. There is no footpath along Thorn Street for pedestrians who would be at more risk with increased traffic. It would be a concern if Thorn Street received more traffic as a result of this proposal.

Access to and from Avon Terrace

The intersection of Stephen Street and Avon Terrace can be dangerous. Vehicles are commonly parked very close to the intersection, even in the no parking area, and there is little visibility for vehicles trying to exit from Stephen Street. Even when cars are legally parked, the view of oncoming traffic is blocked and exiting cars need to pull out almost completely onto Avon Terrace before they can see if the road is clear. We have corresponded with the Shire on previous occasions over the years about this concern but the problem continues. A rubbish bin in front of Spooky Hall also partly blocks the view of oncoming traffic.

Parking needs to be moved further from the intersection to improve visibility and illegal parking needs to be better monitored. Some years ago we believe the Shire had a plan to widen the footpath and kerbs in this area which would have helped solve this problem.

As a follow up on our meeting, Bob and I did a quick canvass of the businesses in the main street yesterday and the almost absolute majority didn't want the RV's moved.

The re-formed chamber of commerce (if that's it's correct name), under the stewardship of Rob Garton-Smith are also organising opposing the re-location.

I have attached our support letter, the original we will give to David Wallace who we have arranged to see on Friday after Thursday's council discussion group meeting.

On another subject, please help our Croquet club in keeping the finished floor level as low as possible. Not only to keep the building cost down as to reduce it's visual impact from across the river and also the streetscape view. I believe the FFL is the last hurdle to a final approval. Ideally can we beg to have the level the same as the present building as there has never been any floodwater anywhere near as high as the present level, and council do have the power to classify it as an uninhabitable building with an exemption to avoid the theoretical 100 year flood heights.

While I am running hot the Avon Valley Motor Museum acquisition is looking like it will happen soon.

YORK FREE CAMPING IN AVON PARK

Results of a brief 2 day questionnaire with overnight campers 3-4th November 2017.

There were 13 vans and campervans interviewed and asked the following questions;

1. Where did you find out about the free camp?

Information centre and signs 3 campers, recommendations from others 4, wiki and camps books 6.

2. Would you have come here without the free camping facility?

There were 9 no's and 2 yes with 2 not sure.

3. Have you or do you intend the visit the Motor Museum, Residency Museum or the Courthouse Building?

There were 6 yes and 4 no and 3 likely to.

4. Would you recommend it to others as a good stay?

All agreed to and have suggested to people to visit and stay here in York.

5. How do you rate York as a tourist or overnight destination?

The comments were: Terrific, wonderfully historic, 9/10, very good, one of the best, just beautiful.

6. Money spent here in town?

Each van was, \$0, \$145, \$180, \$120, \$110, \$0, \$220, \$150.\$260, \$280, \$20, \$80, \$30. Average \$122.60 each.

SUGGESTIONS FROM CAMPERS

We could provide a donation box and could collect receipts for money spent in town.

Do not move the site to behind the coffee carriage as the grounds are undesirable especially in summer/winter, no lighting, and too far from services if you want us to recommend York to others.

Half would like a 48 hour stay like Brookton and they would certainly help the town's economy more.

Some liked the possibility of paid showers.

SOME OBSERVATIONS AND COMMENTS WORTH CONSIDERATION

Geraldton council have done several studies and they calculate each free caravan camper there spends an average of \$150 each per day.

Our estimate is 80% are around the 60-70 years of age bracket love travelling Australia and country towns. They have money and will spend it. Most rigs valued at \$150-250,000.

There is a significant Caravan association estimate of around 500,000 caravan-RV travellers on the roads at any time Australia wide. With more coming to WA each year.

With relatively recent spike in new caravans being sold the momentum is upward and if we in York don't try our hardest to accommodate them the other neighbouring shires will.

Most are internet savvy, with facebook and social media connections.

SUMMARY

Keep the RV friendly "flag waving", don't move the current location.

Perhaps an overflow area across the river near the croquet courts. Apparently vandalism has been greatly reduced since the initiative has been in place.

Put in a donation box to show some "doubting Thomas's" that people will pay their share.

By actively supporting free camping at Avon Park, Council policy will continue to greatly benefit town businesses and vitality the flow on will improve real estate values with a more vibrant and proactive town.

Pro – Spend money in town, pass work around RV friendly town, not much vandalism.


Con – not knowing what background is of caravaners like we say opportunity for not so nice people. Rate payers pay for electricity.


I know caravan park has been issue hopefully new plans new owners will make it more viable for caravaners to be there. We need to support local business.


A walk trail is already joining the Glebe Street Bridge and the Swing Bridge on both sides of the river, and Avon Park offers an attractive recreation area to visitors.

The main benefit of this location to The York Croquet Club would be the security of having the caravans close by.



RECREATIONAL VEHICLES

Dear Paul,

On the basis of samples taken, the York Business Association is of the view that businesses in the town prefer the facility offered to RVs at Avon Park to be retained and not moved.

We can give some reasons for this:

- A number of businesses have evidence that having RVs so close to the centre of town increases spend, particularly when there are no other visitors in town. Examples are IGA, newsagency, bakery, cafes, pharmacy.
- Being more expensive vehicles, RVs are most often owned by more wealthy touring couples who have more discretionary expenditure than might otherwise be the case.
- The facility enhances the goodwill of York. The Visitor Centre apparently has a large number of thank you notes from RVs who have overnighted at Avon Park
- The facility is well known amongst the RV community and this attracts a steady stream of RVs to York. . If this facility is withdrawn we have been told by the caravan community that the updated information will be posted to Wikivans, leading to York being bypassed in favour of other free RV towns.
- The existence of the RV facility provides something positive for RVs against the alternative of the out of town York Caravan Park.

- The RVs provide overnight security for those who use or frequent the park.
- Figures show that since the Council has offered the facility, there has been a dramatic fall in vandalism at Avon Park, outweighing any costs of providing free power by the substantial savings in maintenance and repairs.
- The cost of re-siting the RV parking could be better spent with more positive results in other ways.

We know that *some* ratepayers object to providing free power at the four RV stations where power is available. I imagine that the administrative costs of collecting a small amount from RVs who use this facility would not make it worthwhile. It would be of assistance to the York Business Association, Inc if the Council could kindly provide us with an estimate of the cost of providing power to some of the RVs.

If a charge for power is being considered, it may be worth considering having power decals printed by the Council for display on vehicles. These decals could be purchased from the Council by local businesses, which would then be on-sold to RVs. This would mean very little administrative cost to the Council and would encourage traffic into the participating businesses, and it would be a way of assuaging the minority of locals who feel aggrieved by paying for the RVs' power.
