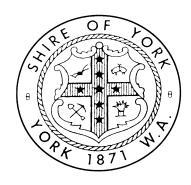

Cr Reid read the following statement at the commencement of Public Question Time:

# Statement by the Presiding Member at the Opening of Public Question Time at Ordinary and Special Council Meetings

"Public Question Time is provided for under the provisions of Section 5.24 of the Local Government Act and the Local Government (Administration) Regulations 1996.

To provide equal opportunity for people to ask questions a limit of two (2) questions per person per time will be applied. If there is time available in Public Question Time people may be given the opportunity to ask a further two (2) questions at a time.

### **Procedures**

- Questions submitted in writing prior to the meeting will be dealt with initially.
- Questions from the floor will be taken in the order recorded in a register.
- Statements, opinions and attachments will not be recorded in the minutes.
- Questions requiring research will be taken on notice and a response will be prepared
  in a reasonable timeframe. The original questions and the response will be included
  in the Agenda and Minutes of the next Ordinary Council meeting.
- Questions may be deemed inappropriate because they contain defamatory remarks or offensive language, they question the competency of elected members or staff, they relate to the personal affairs of elected members or staff, they relate to legal processes and confidential matters or they have been responded to previously and these will not be accepted or recorded in the Minutes.
- The minutes may only record a summary of the question asked and the response given.

- Where possible questions asked should be submitted in writing at the completion of question time or at the end of the meeting.
- At Special Council Meetings questions must relate to the items on the Agenda.
- Shire of York guidelines for Public Question Time are included on the meeting agenda."

#### Question:

Is the final choice of an interim CEO for the York Shire to be made by the Shire President or the Council as a whole?

# Response:

The Shire President stated that the appointment would be made by the Shire President with the support of Council. He is seeking Council to allow him to act and empower.

#### Mr Gordon Marwick

#### Question:

Now that the York Shire Council have agreed to advertise for a replacement CEO to act in a temporary position, 'will the Council selection panel require that person to have a strong financial background and a good understanding of Local Government as part of the requirements to fill this position?'

# Response:

The Shire President stated that he was keen to employ a qualified accountant with Local Government experience. It would be a temporary appointment while the Council advertised widely to fill the position.

# **Mr Anthony Robinson**

### Question:

I endorse Mr Marwick's request for a Shire Clerk to have strong financial credentials but also to have a very strong understanding of running and maintaining the Shire's infrastructure being Shire roads, bridges, pavements, streets and buildings. Would you please ensure that this would be the case?
